Re: Canada Post Corporation Strategic Review Submission

The Town of Two Hills would like to express its concern regarding the Canada Post Corporation's Strategic Review. Our initial concern is in regard to the fact that this review was not advertised nor provided for input from the public in an open public forum. This causes us concern as to how many organizations or communities would have the ability to respond or even know that the review is taking place.

Our next concern is that of the possibility of the postal service being deregulated. Our town is located in North East Alberta and has a very rural population. Deregulation of the postal service may result in loss of service in our community or in our neighbouring communities. As ours is an aging population it is of concern that Two Hills could be without postal service or reduced service. In addition, the Post Office provides several jobs in our community and it could adversely affect both the current employees of the Post Office as well as the community if any jobs are lost. We are looking to retain residents in our Town, not lose them due to the loss of a job.

Finally, what guarantee do we have that deregulation will not result in higher postal rates. The current corporation is not focused on large profits for shareholders, however if new private companies are allowed to enter into the market, they will be for profit and we would likely see postal rates increase.

We ask that this committee hold public hearings and properly consult with the true owner's of Canada Post "The Public".
